For the few, not the many

The renewal of the Coronavirus
Act on Wednesday 30th September with barely a mention in the mainstream media and only a 90 minute debate by Parliament is a clear sign that the planned implementation of 'Agenda 21' is at full throttle, whether most of the population is aware of what is taking place or not.

Although a group of about 85 MP's had tabled an amendment to curtail what the CV Act enables the Government and its authorised officers to do to people, Speaker Hoyle did not include it for debate due to lack of time, despite its obvious popularity and the serious public concerns about the removal of human rights the Act continues to facilitate. Only 24 MP's voted against it and 292 were 'no vote recorded' including most Labour and all SNP Members.

The Act's most dangerous part, Schedule 21, effectively sweeps away

the ancient law of 'an Englishman's home is his castle' and allows police or other officers to use 'reasonable force' to enter any building including your home, work or leisure location without a warrant, and remove you and your family to a centre where you can be tested and treated for Coronavirus and held for 14 days should they require it.

The CV Act could be used to separate those who listen to the science rather than the government under the guise of 'protecting public health,' or any group for any reason in the future. Not often, in recent decades, have government regimes given back the freedoms they have taken under the guise of 'terrorism' and serious crises and emergencies. These laws are rarely temporary.

We believe the only reason there is not mass resistance towards this human rights-stripping legislation laid down in the name of 'public safety,' is the omission of any mention at all of what laws are being passed in the 24/7 mainstream news in 2020, particularly the main evening broadcasts that most people get their 'news' from, whether first or second hand, and which are repeated throughout the day.



Removal of these individual rights and natural freedoms is at the core of what Agenda 21 is about, under the guise of 'saving the earth's resources.'

It promises a transformation from our known way of life to a 'communitarian' society, and is in fact the establishment of a two-tier system where most are restricted from using and enjoying natural resources in the name of preserving them 'for all' and saving the earth. First publicly announced at the United Nations gathering in Rio in 1992. UK: MAKING CRIME LEGAL

Under legislation going before Parliament, MI5, the police, the National Crime Agency and several other government agencies that use informants or undercover agents will be able to explicitly

authorise them to commit a specific crime as part of an 'operation.'

The Covert Human Intelligent Sources Bill will merely require MI5 officers and others to show the crime is "necessary and proportionate"

which is language designed to be so elastic you could twang it from here to Dan Andrews' brutal, human rights-trampling, authoritarian police state in Victoria, Australia and back before you could find a losing argument for 'reasonable and proportionate,' your Honour.

There will also be no role for

the Crown Prosecution Service in reviewing the secret crimes, despite the Security Minister James Brokenshire saying there would be 'robust, independent oversight' - this will be from just one senior judge.

The bill, now past its Second Reading in the Commons, lists 3 very broad uses, leaving the intelligence agencies

with a near-unlimited capacity to not only commit crimes themselves but also authorise others to commit genuine harm against individuals should the bill go ahead unamended:

School tells pupils anyone who disagrees with the Government and the BBC is 'far-right' and should be reported

A school in the West Midlands is reported to have put on a presentation which portrayed those who suspect the Government may not be fully truthful at all times as 'conspiracy theorists' and 'far-right terrorists' that should be reported if these views are heard by them.

In a stunning echo of East Germany, Soviet Russia and 1984, according to reports there was no obvious irony or allusion to this blatant brainwashing to conform to the rulers' line, infinitely echoed ad nauseum through the tightly-controlled broadcast channels.

During discussions in class, one teacher suggested all vaccines are perfectly safe, and the coming Covid vaccine, which is still in trials and has already severely damaged at least 2 victims, would be too. The report goes:

"Myself and two other parents (also on here) have been informed by our children that a presentation was held at their senior school today. Some of it was acted out by teachers in sketches.

The children were told not to listen to any 'fake news' about masks and not to believe anything unless it's on BBC or Sky News. Anything shared on social media is 'conspiracy theories' and should be ignored even if it's claimed it's from scientists!

The school told the children that if they hear anyone talking like that or hear 'things like that' talked about at home then they should report it to student support services or the National Counter Terrorism office!

They actually said to them that if anyone in your family has a minority view that the mainstream don't share then they are 'far-right'.

Oh and one of the teachers decided to take it one step further and tell her class that everyone should take the vaccines as they are 'perfectly safe!"

Notice served to MP's of intended Private Prosecution against them

On 30th September, a notice of intended Private Prosecution was sent to all serving MP's after a grand jury found there was sufficient evidence to successfully gain a likely conviction against the accused in a magistrates' court.

The action was brought by [redacted for security].

The charges read as follows:

Here lies the Notice of Intended Private Criminal Prosecution, which was served upon every serving MP by email this morning, for and on behalf of the British people:

Dear Sirs

You are hereby served notice that it is my intention to lay information in a Private Criminal Prosecution against yourselves, alleging that the following crimes have been committed against the British people:

- 1. Section 2 of the Fraud Act 2006 has been repeatedly breached in the enactment of the Coronavirus Act 2020 [the CV Act] an act which was founded upon a series of dishonest statements relied upon by every serving MP. Namely:
- a. That there was a genuine public health emergency, which justified the draconian measures taken.
- b. That there was a legal basis for such an act to be passed into law.
- c. That there was no viable alternative course of action that could be taken to "flatten the curve" of alleged COVID-19 deaths.
- 2. In addition, the CV Act unlawfully purports to have suspended the democratic right of every Briton to remove the government from office, as well as the individual rights guaranteed by the Common Law, which are beyond the jurisdiction of the legislature.
- 3. The CV Act also purports to have legislated for the falsification of death certificates, which has enabled the government to grossly inflate the number of people who have

reportedly died of the Covid-19 virus, which in any event has never actually been proven to exist.

- 4. Nevertheless, the ONS data shows that the government policy which was enabled by the CV Act doubled the average five year UK mortality rate, which is considered tantamount to genocide under international law, when the fatal refusal of care to patients in care homes and hospitals is taken into account.
- 5. Furthermore, the enactment of the CV Act also comprises a fundamental breach of the Treason Felony Act 1848, in that it treasonously purports to authorise ministers of the Crown to govern the People by royal decree or proclamation, which is strictly prohibited by articles 1 and 2 of the Bill of Rights 1689.
- 6. In any event, as Lord Coke, the draftsman of the Petition of Right, said in the 1610 decision of Thomas Bonham v College of Physicians 8 Co Rep 107a; 77 Eng Rep 638, commonly known as Dr. Bonham's Case, in the Court of Common Pleas:

"In many cases, the common law will control Acts of Parliament, and sometimes adjudge them to be utterly void: for when an Act of Parliament is against common right and reason, or repugnant, or impossible to be performed, the common law will control it and adjudge such an Act to be void."

Should you collectively move to set aside the act which the Common Law ajudges to be repugnant, as well as void ab initio, as per the Dr Bonham case, no later than the midnight on the 2/10/2020, this action will be suspended.

However, in the event you fail to do so, for any reason whatsoever, a QC and legal team will be engaged to lay the information before a court of competent jurisdiction at the earliest opportunity and the Private Criminal Prosecution will commence.

Please be advised that a Grand Jury of the People has already determined that there is sufficient evidence to indict every MP for fraud, treason and genocide. This is your last chance to leave your mark on the right side of history because there is no jury that would not convict every complicit member of Parliament on the charges that will be laid.

Nevertheless, I trust you will see the devastating error you have made, before it is too late.

Last Chance

This notice represents the last opportunity that every serving MP has to put right their wrongdoings against the People and was served upon them all this morning 30th September 2020, as they prepared for a Parliamentary debate about whether the unlawful and void Coronavirus Act 2020 should be applied for another six months.

Darpa and Gates Foundation help develop nanochip for vaccines

The Department of Defense, and the Bill and Melinda Gates Foundation, have partnered with a Silicon Valley company, Profusa, to implement a technology which could control our minds and bodies. What may seem like science fiction, is in fact happening in real-time.

A permanent chip made of an advanced material called hydrogel irreversibly ties humans to the internet 'cloud.' The chip, about 5mm long, provides feedback to a database on changes in body chemistry and other biometrics. The company says technology will be used to detect Covid and other diseases in the general population, before symptoms show.

The latest revised CDC overall survival rate for the Covid virus is 99.8%, versus 99.9% for the common 'flu. Nevertheless, nearly 150 days after governments proclaimed that 15 days of "lockdowns" and social distancing would be necessary to "flatten the curve" so that hospitals would not be overwhelmed, US governors still exert emergency powers based on the announcement of 'new cases.'

A defense industry website Defense One reports that the chip implant could win FDA approval by early 2021: "Profusa says the sensor is on track to try for FDA approval by early next year."

The industry magazine writes effusively: "Why are pandemics so hard to stop? Often it's because the disease moves faster than people can be

tested for it. The Defense Department is helping to fund a new study to determine whether an under-the-skin biosensor can help trackers keep up — by detecting flu-like infections even before their symptoms begin to show."

The hydrogel chip biosensor is a soft, flexible fibre designed to be biologically compatible with the body's tissues for continuous monitoring, while overcoming the effects of local inflammation or rejection.

Along with the advent of in-body nanotechnology, and sensors which tie the human body to an artificial intelligence platform, the possibilities for misuse by totalitarian governments has not been lost on privacy and freedom watchdogs. With advanced biosensors, artificial intelligence may be able to read the subject's every mood and activity, heart rate, respiratory rate, body temperature, even sexual activity.

Technology critic Adam Keiper writes in The New Atlantis: "Nanotechnology could theoretically be used to make mind-control systems, invisible and mobile eavesdropping devices, or unimaginably horrific tools of torture."

DARPA, the Defense Advanced Research Projects Agency which is an arm of the Department of Defense, partnered with Profusa, an Emoryville, CA-based biotech company, to develop the technology in 2011.



A Profusa Press Release from March 2018 states: "today scientists are presenting results showing tiny biosensors that become one with the body...stream data to a mobile phone and to the cloud, and that are painlessly placed under the skin with a single injection."

BioOptics World, an industry magazine, describe Profusa sensors as "Injectable biosensors that become one with the body's tissue."

The Bill and Melinda Gates Foundation grant is described as "Implantable multi-analyte sensors for the continuous monitoring of body chemistries."

Development of In-Body Nanotechnology Which Could Be Combined with Biochips One of Profusa's principle investors, according to a company profile, is the US Army Research Office. At the same time in-body hydrogel technology is being developed, in-body nanoparticle technology is being developed as well.

The Department of Defense makes no attempt to hide its desire to use nanotechnology to develop "supersoldiers" who do not need to sleep, have heightened sense awareness, and other "battlefield" advantages, regardless of long-term side effects to health.

In the past, the health of soldiers has seemed an afterthought to a military establishment which has exposed its soldiers to Agent Orange, and experimental Gulf War vaccinations against biological agents.

A widely deployed mass surveillance platform would require enormously increased capacity in cellphone and wifi networks. Some say this is one reason governments are driving so hard to replace current networks with 5G.

Profusa is also working on research with Imperial College, another benefactor of Gates largesse in the area of vaccinations. Imperial College is the institution from which sprang the ill-fated study by Professor Neil Ferguson which predicted over half a million dead in the UK without social distancing.

Prof. Ferguson has been roundly discredited as wrong on all counts.



You read that right – the British establishment ordered that a respected medical doctor who had been flown in from Germany be arrested, handcuffed, bundled into a van and kept locked up at Wandsworth police station for 22 hours. At Speaker's Corner.

A little time earlier, around 3pm, Riot police had also come steaming in with batons raised (and used) on a large assembly of around 40,000 in Trafalgar

Square, who had been peacefully

the equipment in the middle of Dr. Heiko's speech, most of the crowd marched down Oxford Street to Hyde Park, surprising and delighting shoppers, and it was there another large crowd gathered to hear Dr. Heiko speak for a further 8 or 9 minutes, before the riot police were again instructed to mob-handedly arrest the peaceful Dr. Schoning.

He then spent the next 22 hours in custody at Wandsworth police station despite no law being broken. Coming out to a hero's welcome before finally getting to do his speech unhindered. It is likely his story and profile have now been seen by many more because of his arrest than if they had just left him alone

It seems the regime are censoring the truth wherever they can, and in any way they can - they certainly didn't want the people to hear this doctor's opinion.

Dr. Schoning is only one of thousands of medical and other professionals speaking out against the Governments' constant fear stories and draconian responses (see opposite,) calling coronavirus no more deadly than the 'flu, and which can be treated using medicines that have been around for decades

Dr. Schoning had also said at the Inquiry Committee, concerning Germany: "According to an internal report from the Federal Ministry of the Interior, 90% of all necessary operations in Germany were not carried out, which affected 2.5 million people. This report also states that there are or will be 5,000 to 125,000 deaths resulting from these government measures. These are human beings, fellow citizens who have already died or are still dying. This report was dated May 7, 2020. This is also the reason why we are now taking this Corona investigation into our own hands because we can no longer wait.

It is more than grossly negligent that government agencies do not disclose these things and, as it seems, orchestrate them, because the scientific data already shows that there is no basis for these measures. We all ask ourselves – of course also in business, but this is mainly about human lives – who benefits? That's a question we will also try to find answers to. Cui bono? Who benefits?"

Just why does Scientist Piers Corbyn keep getting arrested?

Back in April during the first lockdown, Piers Corbyn was already issuing a rallying cry to those who had questions, and for resistance to the measures being enforced by the UK Government on the back of its overreaching 'Coronavirus Act 2020'. From a handful of concerned citizens to now over 40,000 attendees at monthly London rallies, Piers has been there since the beginning.

A sinister vision of our potential future, where advances in technology mean the creation of a full surveillance state is only a few more clicks away, is part of the reason he feels we should all become informed on this social crisis.

"The protagonists of the 'Great Reset' are trying to impose something very similar to the Chinese Big Brother system. All aspects of the Covid measures are anti-human and reduce liberty. Health Passports and digital ID are horrific attacks on freedoms and are intended to control everybody. As individuals and collectively we must refuse and oppose all these measures".

The conversation flows into discussion of the types of technology creeping into our lives, from the Track & Trace app to the LG ThinkQ home of the future - a lot of which Piers describes as part of the so-called 4th Industrial revolution/technocracy, and as 'scary dehumanising stuff.'

Artificial intelligence and Big Data do have the growing capabilities to control the behaviour of us all, especially in the hands of governments who are known to be corrupt at best.

Piers believes "5G is key to all of this artificial intelligence diktat. The technocratic agriculture requires 5G over the whole country. To monitor and control farm machines, animals and humans. Farmers are generally unaware of what is in store for them," and it's not hard to be alarmed at the dystopian potential of these technologies.

Many of the public may be sleepwalking into a new world: "Health Passports and vaccinations are a tool of coercion. The likely consequence of the first vaccine will be people needing vaccines every year. All of this will make bonanza profits for big pharma.

The combined net asset value of Gates, Zuckerberg and Bezos has also increased by \$150 billion dollars since March. This is \$20 for every man, woman and child on earth.

These measures will be used to control us more and more if they get away with it. There will be increasing resistance and increasing disrespect for the existing 'democratic' process, and then attempts by the ruling circles to impose martial law on a permanent basis (as in George Orwell's book '1984'). But this could be defeated by actions which make the local state, such as the police, inoperable, and open the door to new forms of society."

This is because they damage your immune system. All the Covid vaccine programmes should be halted now. They're dangerous and only big pharma benefits.

Sir Patrick Vallance, a chief advisor on Covid, has £600k in personal shares in vaccine maker GSK, a company he used to work for. This conflict of interest is unacceptable and shows the system is corrupt". Doctors such as Vernon Coleman have plenty of information online for readers to check out about these subjects.

It seems Piers has a lot of knowledge and conviction, which

shows why he has become an unlikely poster child for standing up for human freedom here in the UK. He asked me to leave the readers with a clear three point message.

"Beware the policeman in your mind, we are all being slowly brainwashed into a dystopia.

We must seize every opportunity locally, nationally and across the world to push back their narrative. Success will be uneven. Local action groups, nationally coordinated as far as possible, are needed to have targeted actions and common demands.

The CDC document is titled, "CDC 2019-Novel Coronavirus (2019-nCoV) Real-Time RT-PCR Diagnostic Panel." It is dated July 13, 2020.

Buried deep in the document, on page 39, in a section titled, "Performance Characteristics," we have this: "Since no quantified virus isolates of the 2019-nCoV are currently available, assays [diagnostic tests] designed for detection of the 2019-nCoV RNA were tested with characterized

stocks of in vitro transcribed full length RNA..."

The key phrase there is: "Since no quantified virus isolates of the 2019-nCoV are currently available..."

Every object that exists can be quantified, which is to say, measured. The use of the term "quantified" in that phrase means: the CDC has no measurable amount of the virus, because it is unavailable. The CDC has no virus.

A further tip-off is the use of the word 'isolates." This means **no isolated virus** is available.

Maryland man jailed for one year following multiple parties during virus lockdown

Amaryland man who held multiple large gatherings during lockdowns in violation of Governor Larry Hogan's public health order, banning groups over ten or more people, was sentenced to one year in jail, reported WJZ Baltimore.

Judge W. Louis Hennessy sentenced Shawn Marshall Myers, 42, of Hughesville, to one year in jail on Friday (Sept. 25) for failure to comply with an emergency order.

Myers threw multiple parties on his property; in some cases, more than 50 attendees were counted by the local law enforcement agency in late March, which was around the time the virus pandemic erupted.

According to the Charles County Sheriff, the first party was held on March 22, and had between 50 to 60 people present. "Myers was argumentative with officers but eventually agreed to disband his party," according to the State's Attorney.

Five days later, on Mar. 27, officers responded to Myers' home for a second time, finding more than 50 people partying. At that point, he was arrested. "Officers told Myers to disband the party, but again he was argumentative claiming he and his guests had the right to

congregate," the State's Attorney said. "Beyond being argumentative, Myers directed his guests to stay, in defiance of Governor Hogan's orders and the officers' orders to disband the party."

In addition to a jail sentence, Myers was handed a \$5,000 fine and ordered to serve up to three years of unsupervised probation upon his release. Readers may recall Myers wasn't the only one hosting parties during lockdowns. Millennials threw wild parties as a game to infect each other so they can "get it over with" and get the antibodies, much like we used to do with the chicken pox.

Israel limits protests in new coronavirus lockdown law

I srael's parliament approved a government-backed edict on Wednesday likely to stifle protests against Prime Minister Benjamin Netanyahu over alleged corruption and his handling of the coronavirus crisis.

The legislation, ratified after an all-night debate in the Knesset, bans Israelis from holding demonstrations more than 1 km (0.6 miles) from their homes, a measure the government said was aimed at curbing Covid-19 infections.

Critics of the new measure, which becomes part of Israel's second national lockdown that went into effect on Sept. 18, said it was really intended to block protests near Netanyahu's official residence in Jerusalem.

"What's the next step? Banning the opposition leader from addressing parliament?" Yair Lapid, who heads the opposition in the legislature, tweeted about the vote.

For weeks, thousands of demonstrators have gathered to call for Netanyahu's resignation.

Opinion polls show only about a quarter of the public has confidence in the way he has dealt with the pandemic, which had largely subsided during a March-May lockdown.

New road between Russia and China

The highway bridge linking Russia and China over the Amur River is expected to be operational as soon as November, according to Amur Oblast Governor Vasily Orlov. The bridge is set to boost economic ties between the two nations by increasing volume eight-fold.

"The infrastructure and all the services are ready. We expect that the bridge will be opened in November," said Governor Vasily Orlov.

The ambitious \$300 million construction project began in Dec 2016 and was completed in Nov 2019.

The bridge links the cities of Heihe in

northern China and Blagoveshchensk in Russia's Far East that are located on opposite banks of the Amur River.

The structure is more than 0.6 miles long and is a part of a key

12.4 mile two-lane highway project between Russia's oil and gas fields and communist China. It will only take cargo for the first 1.5 years of its operation, before opening up to passenger traffic.





Sanctions imposed on Belarus after President refuses IMF

The British and Canadian governments imposed sanctions, on Tuesday, against long-time Belarusian president Alexander Lukashenko, along with his eldest son Viktor, and six other high-ranking officials in the state apparatus.

The sanctions mean that those on the list are banned from travelling to the UK and Canada, and any assets they hold in those countries will be immediately frozen. Lukashenko is the first world leader to be targeted by the new UK Global Human Rights sanctions regime.

"Alexander Lukashenko's regime is responsible for a string of human rights violations against opposition figures, media, and the people of Belarus in the wake of rigged elections," the British government's statement said. "Despite numerous calls from the international community, he has refused to engage in dialogue with the opposition, choosing instead to double down on his violent repression."

The statement quoted British Foreign Secretary Dominic Raab, who unironically explained that the sanctions were imposed "in response to the torture and mistreatment of hundreds of peaceful protestors."

In the Canadian government's statement, Minister of Foreign Affairs François-Philippe Champagne said his nation was standing "in solidarity with the people of Belarus as they struggle to restore human rights and achieve democracy in their country."






There are six further sanctioned officials outside of the Lukashenko family, and the history of sanctions from the Western powers is always incremental, beginning with the leadership and eventually spreading to the population in general - Iran & Syria are two recent examples of crippling sanctions imposed on governments that do not comply.

Lukashenko was elected for a sixth term as the Belarusian president on August 9th, in a contest many consider to have been rigged. According to the official results, he received 80% of the vote, with opposition candidate Svetlana Tikhanovskaya only receiving 10%.

In the same week the British Government sent in riot police to break up a mass peaceful political meeting for the second time running, it seems no irony is lost on the UK and other Western regimes in admonishing other countries for cracking down and trying to de-legitimise peaceful opposition, when we have seen it from them time and again.

Not only the attack on human rights in Trafalgar Square on the 19th and 26th of September, but the harsh and inhumane treatment of journalist Julian Assange who helped expose U.S. war crimes during the illegal Iraq war and is now being held in Belmarsh Prison pending a final decision on his extradition on Jan 4th 2021.

China's economy recovering well, figures show



hina's official manufacturing **∠** Purchasing Manager's Index (PMI) for September has come in at 51.5, as compared to 51.0 in August, according to its National Bureau of Statistics (NBS). A figure above 50 indicates expansion.

The reading was above analysts' expectations; polling by Reuters projected the index to come in at 51.2.

The positive performance of the key sector was driven by strong export and import orders. Indicators showed the expansion of these for the first time this year, at 50.8 and 50.4 respectively, in September – 1.7 and 1.4 points up from August. The long holiday also spurred consumer demand. Zhao said. according to CNBC. In particular, production of and new orders for food, alcohol, beverage and tea expanded at a faster pace in September compared to August, he pointed out

Russian Arctic shipping route up by 32%

The volume of cargo transported via Russia's Northern Sea Route is constantly growing and could top expectations by the end of the year, said Director General of the **State Atomic Energy Corporation** Rosatom Alexey Likhachev.


Rosatom is an infrastructure operator for the route.

"The plan for this year's freight traffic along the Northern Sea Route was 29 million tons, but today our forecast is that it will exceed 32 million tons," Likhachev told

Rossiya 24 TV channel. Earlier, he said that by 2024 the volume of freight transportation via the NSR could reach 92.6 million tons.

The NSR, which stretches the entire length of Russia's Arctic and Far East regions, is expected to become a major trade route for goods shipped between Europe and Asia.

According to President Vladimir Putin, the route is "the key to the development of the Russian Arctic regions of the Far East," and the goal is to make it a "truly global, competitive transport artery.'





Banks caught laundering over \$2 Trillion for criminals


Major international banks have been accused of laundering huge sums of money for many years, in spite of warnings about the sources of the cash, according to investigative journalists, who have cited confidential documents submitted to the US Treasury's specialist Financial Enforcement Network (FINCEN.)

The latest expose by the International Consortium of Investigative Journalists (ICIJ) and media partners around the world is based on leaked Suspicious Activity Reports (SARs) that banks and financial firms file with FINCEN.

The files allege that five banks — JPMorgan, HSBC, Standard Chartered Bank, Deutsche Bank and Bank of New York Mellon — "kept profiting from powerful and dangerous players even after US authorities fined these financial institutions for earlier failures to stem flows of dirty money".

They moved large sums of allegedly illicit funds over a period of nearly two decades despite red flags about the origins of the money. More than 2,100 Suspicious Activity Reports were obtained by BuzzFeed News and shared with the International Consortium of Investigative Journalists (ICIJ) and other media organisations.

In all, the ICIJ reported that the files contained information about more



than \$2 trillion worth of transactions between 1999 and 2017, which were flagged by internal compliance departments of financial institutions as suspicious.

The SARs in themselves are not necessarily proof of wrongdoing, and the ICIJ noted that the leaked documents were a tiny fraction of the reports filed with FINCEN. They provide key intelligence in global efforts to stop money laundering and other crimes.

Banking system 'under-resourced and overwhelmed'

Media reports on Sunday painted a picture of a system that is both underresourced and overwhelmed, allowing vast amounts of illicit funds to move through the banking system.

A bank has a maximum of 60 days to file SARs after the date of initial detection of a reportable transaction, according to the Treasury Department's Office of the Comptroller of the Currency. But the ICIJ report said in

some cases the banks failed to report suspect transactions until years after they processed them.

The SARs also showed that banks often moved funds for companies registered in offshore havens, such as the British Virgin Islands, and did not know the ultimate owner of the account, the report said. Staff at major banks often used online searches to learn who was behind large transactions, it said.

Among the types of transactions highlighted by the report: funds

processed by JPMorgan for potentially corrupt individuals and companies in Venezuela, Ukraine and Malaysia; money from a Ponzi scheme moving through HSBC and money linked to a Ukrainian billionaire processed by Deutsche Bank.

"I hope these findings spur urgent action from policymakers to enact needed reforms," said Tim Adams, chief executive of the trade group Institute of International Finance, in a statement. "As noted in today's reports, the impacts of financial crime are felt beyond just the financial sector – it poses grave threats to society as a whole."

"By utterly failing to prevent largescale corrupt transactions, financial institutions have abandoned their roles as front-line defenses against money laundering," Paul Pelletier, a former senior U.S. Justice Department official and financial crimes prosecutor, told ICIJ. He said banks know that "they operate in a system that is largely toothless."

In response, HSBC and Deutsche Bank made diversionary statements to say the crimes were historical, with the other 3 paying lip service to 'following the law' and spending many millions in teams dedicated to 'fulfulling our obligations.'

All five have been repeatedly found to have violated their official promises of good behavior, the secret records show.

U.S 10 Yr Treasury Yield: 0.775% (TradingView) Former Deutsche Bank AG traders Cedric Chanu and James Vorley were convicted for manipulating gold and silver prices on Friday after three days of deliberation by a Federal jury in Chicago.

The two were accused of making fake trade orders between 2008 and 2013 to influence the prices of precious metals. Their trial was a week long and was the first of its kind since 2010, according to Bloomberg.

The convictions come as the result of a crackdown on "spoofing", placing orders with no intention of executing them, in order to move the price of the underlying product. Spoofing works by fooling the market into thinking there are more bids or offers than are legitimately there. It has been illegal since 2010's Dodd-Frank act.

Chanu and Vorley were said to have "weaponised" this tactic to mislead other traders, according to prosecutor Brian Young. The traders knew what they were doing, the prosecution argued, with Vorley even writing in a message to Chanu at one point: "This spoofing is annoying me. It's illegal for a start."

A co-worker at Deutsche Bank acted as witness during the trial and told the jury that Chanu and Vorley taught him how to manipulate prices by spoofing.

The defendants didn't call any witnesses but instead raised the issue of how difficult it was to try and prove criminal intent for "spoofing" in competitive global markets.

"If you fake a pass and run the ball, that's competition, not fraud," Vorley's lawyer said.

Chanu was convicted on seven counts of fraud and Vorley was convicted of three counts. They were found not guilty on charges of conspiracy. The government has said they are going to seek about four or five years of jail for each person. Vorley said he will appeal and that he was trading "well within the law".

The security and public health innovations rolled out in response to Covid-19—biometric tracking, contact tracing apps, remote education and employment, closure of offices and reclamation of land, monitoring of public utilities, and the like—conveniently coincide with the impact-driven Agenda 21 vision of an urbanised, digitised, and optimised 'sustainable future.'

No more criminals getting away because of too many donuts – Sergeant 'Atlas' is always available 24/7 and will be able to go everywhere thanks to Big Data, The Internet of Everything, AI, 5G and these incredible advances in robotics. We would also always do well to remember, these are just the ones they're showing us.

Another video from Singapore shows robot dogs patrolling a park, in an eerie reality echo of Black Mirror's 'Metalhead' episode, presumably able to instantly adapt to whatever latest edict has come down from the rulers in the previous five minutes as regards to socialised group size allowance and muzzle compliance. The dog announces instructions in a gentle android female voice every few minutes like they do in supermarkets today, and with the ability to count how many of us are gathered together to enforce the latest rules.

Those who thought that stairs would stop the machines taking over will also be disappointed - 'Spot' can climb and descend stairs and also open door handles. In this way it acts and looks more like a monkey in action.

Boston Dynamics has been selling its Spot robot dog/monkey to select research facilities for around a year

now, but the company has announced that businesses in the United States are able to purchase it directly from their website.

At \$74,500, Spot's modular platform is designed to be easily-configurable using a number of accessories and add-ons available.

This may also help explain or begin to offer reasons for what seems like funded antagonism in cities, towards strife, civil war, and calls for disbanding public police forces currently taking place in many places across the world today. 

If man-eating tigers or plague-ridden neighbours were roaming the streets, we'd be in our homes even if the government ordered us out of them.

We are in our homes or wearing masks because the government ordered it and I guarantee that not one of you has ever had a personal experience of the virus where you could say: "yes, your honour, I saw him with my own eyes, clear as I'm seeing you." You do not have that capacity. You are relying on reports. Government reports.

Now, far be it from me to question the government. They are our Elders, wise beyond measure, pure in heart and soul, impervious to the appeal of the titans of commerce and an elite who could spend more on champagne in a month than you could earn in a lifetime, and they wouldn't notice.

There is no reason to mistrust the government.

So, taking it out of Covid for a second, if the government reported

that an alien invasion was levelling villages and killing people in their thousands, it is just a simple and terrifying truth.

Anyone posting videos of those villages, untouched, going about their life, is 'a conspiracy theorist.'

But if it should happen that the government posted their Weekly Stats of Deaths and Causes and listed Deaths By Disintegrator Ray: NIL, now there's a problem.

The government says people are dying by disintegrator ray in their thousands. The government says that no one has died by disintegrator ray. One way or another, the government is lying.

That is why my work these past six months has been almost entirely focused on government data. If the data shows that the government has been telling porkies, well... it's Government vs Government. One way or another, the government is lying.

Our elders lying? I know it's a shock. But it's their data. Difficult to get around that.

From six months' work I can share two fundamental principles that I think people can relate to fairly easily.

If you have Measles in Australia, and Measles in the USA or in Britain,

I think it's fair to say that you'd expect the same sort of results. It's the same virus or disease. Some minor variation, in timing perhaps, or based on Europe being more densely packed. But broadly, it should be the same sort of experience.

Africa, poor and disease-ridden, would likely be having a harder time of it. Fortunately, with all our wealth and resources, we should, as Cuomo boaste, be the best prepared to deal with any health crisis.

So... if I was to list the impact of Covid-19 worldwide, we should expect a broadly similar experience, with maybe Africa suffering disproportionately, but we can always send them aid and support, if that's the case.

So... take a moment to consider which countries you believe would be the hardest hit, based on their unpreparedness, their lack of funds, their poor history of disease.

We're going to use a ranking from 24th June, at the height of the drama. There's been a slight change lately, a rather bizarre and distracting one, so let's make this rather easy to grasp, and we can cover the shift perhaps in later articles.

Drum roll... handkerchiefs at the ready for Africa, devastated by Covid-19... and... Obviously I've

given you the wrong list. Those are the countries that handled it best. No, that's a very real listing of the worst hit nations (including a couple of US cities to reinforce the point).

Now, question for Political Science majors: what would you say were the three most significant centres of Western political and economic power? How about USA/New York, Belgium/EU HQ, and the UK? USA + UK = War of Terror.

These are the power centres... the wealthiest, most powerful, most advanced centres of WESTERN society, and they aren't just a little bit worse hit. By comparison to the Far East (South East Asia and Western

Pacific) and South East Asia on its own, New York City has been hit 485 times worse, 582 times worse.

"It's a city." So is Singapore.

The EU, Belgium, 153 and 184 times worse respectively. The UK, 115 and 138 times worse, respectively. And each of those – NYC, Belgium, UK – implemented stringent lockdowns.





Those times 'science' got it wrong

Modern man likes to extol the virtues of science and wax lyrical about how the marvels of modern medicine enrich and prolong the lives of many people who would otherwise be doomed. With hindsight, however, we learn valuable lessons.

ne of he biggest ever manmade medical tragedies was Thalidomide, also known as Distaval in the UK. The 'wonder drug' was aggressively marketed in the mid-late 1950s as a sedative medication for anxiety, insomnia and morning sickness yet it had not been tested on humans and any potential side effects were unknown.

Heinrich Mückter, the scientist credited with its invention, was a Nazi war criminal who conducted medical experiments at the Buchenwald concentration camp in Poland and caused the deaths of countless people Mückter fled to Germany and evaded prosecution for his crimes, becoming the Head of Research at Chemie Grünenthal, the company that licenced the use of the drug.

By 1958 a number of birth defects were reported in West Germany but the cause was unknown and erroneously attributed to nuclear testing. The side effects of Thalidomide were proven in 1959 and again acknowledged in 1962 but the pharmaceutical giant continued to market the medicine well into the 1970s. The drug caused irreparable harm to 24,000 infants throughout the world and many more babies were miscarried or euthanised on delivery

In 1968, Chemie Grünenthal executives were tried for Involuntary Manslaughter but proceedings were halted due to the 'minor guilt' of the defendants and lack of public interest in the trial. Mückter was never held to account for the death and devastation he caused and died in 1987.

Mercury, a known neurotoxin and endocrine disruptor, was first used in dental fillings in the 19th century. Despite the American Society of Dental Surgeons' requiring its members to not use amalgam fillings, they continued to be used throughout the world

and have only recently been banned in 28 countries for use in children and pregnant women.

There are hundreds of studies that show mercury is hazardous to human health. Elemental mercury can accumulate in brain tissue and leech into food

was first synthesised in 1874 but its potency as an insecticide was not discovered until 1939. Before DDT, countless millions of people died worldwide due to illnesses such as malaria, typhus, yellow fever and bubonic plague.

While DDT has helped in the fight against malaria, and remains in use, it is hard to avoid the

is well known. DDT, which is sprayed heavily on crops and present in the food we eat, breaks down to DDE in the human body and accumulates over time because it is water insoluble and therefore stored in fatty tissue.

Exposure to the chemical can cause nervous system damage, congenital disabilities, male infertility,

and saliva. Fillings expand and contract with exposure to different temperatures, causing cracks and fractures in teeth. Over time, the amalgam corrodes and vapour is released. Symptoms of mercury poisoning include: sweating, tremors, faster than normal heartbeat, addiction, memory loss, depression, cancer, thyroid disorders, Parkinson's and dementia.

Dichlorodiphenyltrichloroethane (more commonly known as DDT) is another chemical that has caused issues throughout the world. It





negative impact it has had on wildlife, due to the destruction of habitats and food sources. The widespread use of the chemical agent saw a decline in bird populations as their eggshells became so fragile that many of them shattered before hatching.

In 2004, 170 countries signed the Stockholm Convention on Persistent Organic Pollutants, restricting the use of DDT to emergencies (such as a malaria outbreak). It was hailed as a wonder chemical but its toxicity miscarriage and developmental delay. Girls exposed to DDT before puberty are five times more likely to

develop breast cancer in middle age.


Toiletry company Johnson & Johnson has recently paid out \$4.69 billion after 12,000 women sued them for damages following diagnoses of ovarian cancer. The plaintiffs alleged that J&J's talcum powder products were contaminated with asbestos and that the company had known about it and kept it quiet.

Paediatricians have warned the public against the use of baby powder for decades because of the risk of aspiration and choking. Cases of infant death caused by inhalation of talc date back to the 1960s. A 2016 Epidemiology study shows genital talc application increases ovarian cancer risk by 33%. Another study found that talcum powder usage was common for 63% of women with ovarian cancer.

Glyphosate is a chemical herbicide used to control weeds, which is sold as 'Round Up.' It is used in parks, playgrounds and cities and is easily available to buy, despite being a known carcinogen. It is genotoxic and an endocrine disruptor; exposure to it can lead to chronic health and developmental problems. Seeds are genetically modified in order to be resistant to glyphosate as the chemical is sprayed heavily on crops. It is harmful to the environment in myriad ways: it destroys wildflowers and insect habitats and because it is water-soluble it has considerable negative effects on aquatic life; its use binds micronutrients to the soil and causes deficiencies in plants.

The Monsanto Company has been ordered to pay \$10 billion to plaintiffs in a class action law suit. The claimants allege that they developed Non-Hodgkins Lymphoma following exposure to the glyphosate-based Round Up. Lawyers claim the company knowingly covered up the health risks of the weed killer by collaborating with insiders from the Environmental Protection Agency to deny any cancercausing effects. It was also discovered that Monsanto funded front groups to discredit scientists coming forward to report the harm caused by the product.

Bayer bought out Monsanto in 2018 and is now threatening bankruptcy if the plaintiffs do not agree to their terms. Appeals are still pending and many claimants have had their settlements reduced. Many of those involved in the class action suit have received no pay out at all, as of this writing.
