Dear Mr / Mrs _____

I am writing to you with regards to the Covid-19 vaccine, which is being heavily promoted by the Government, the NHS, and the mainstream media. 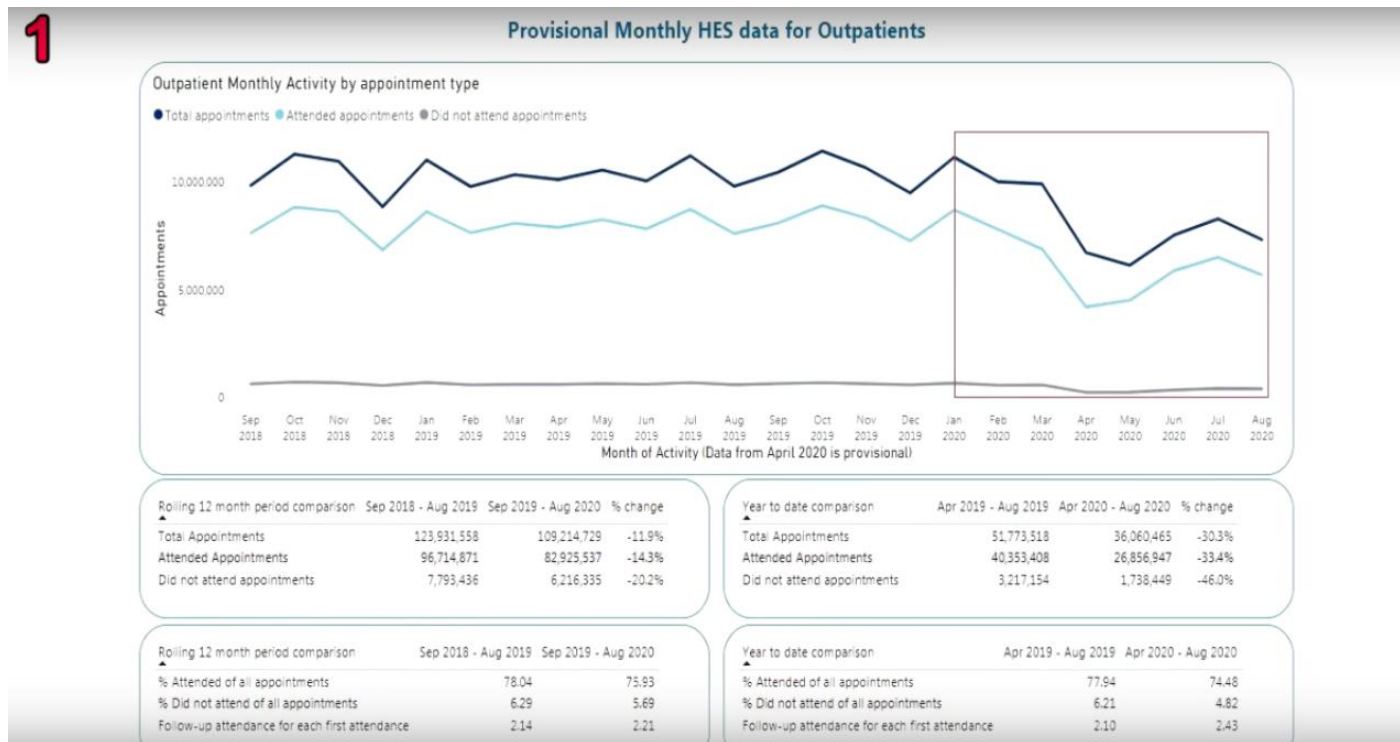

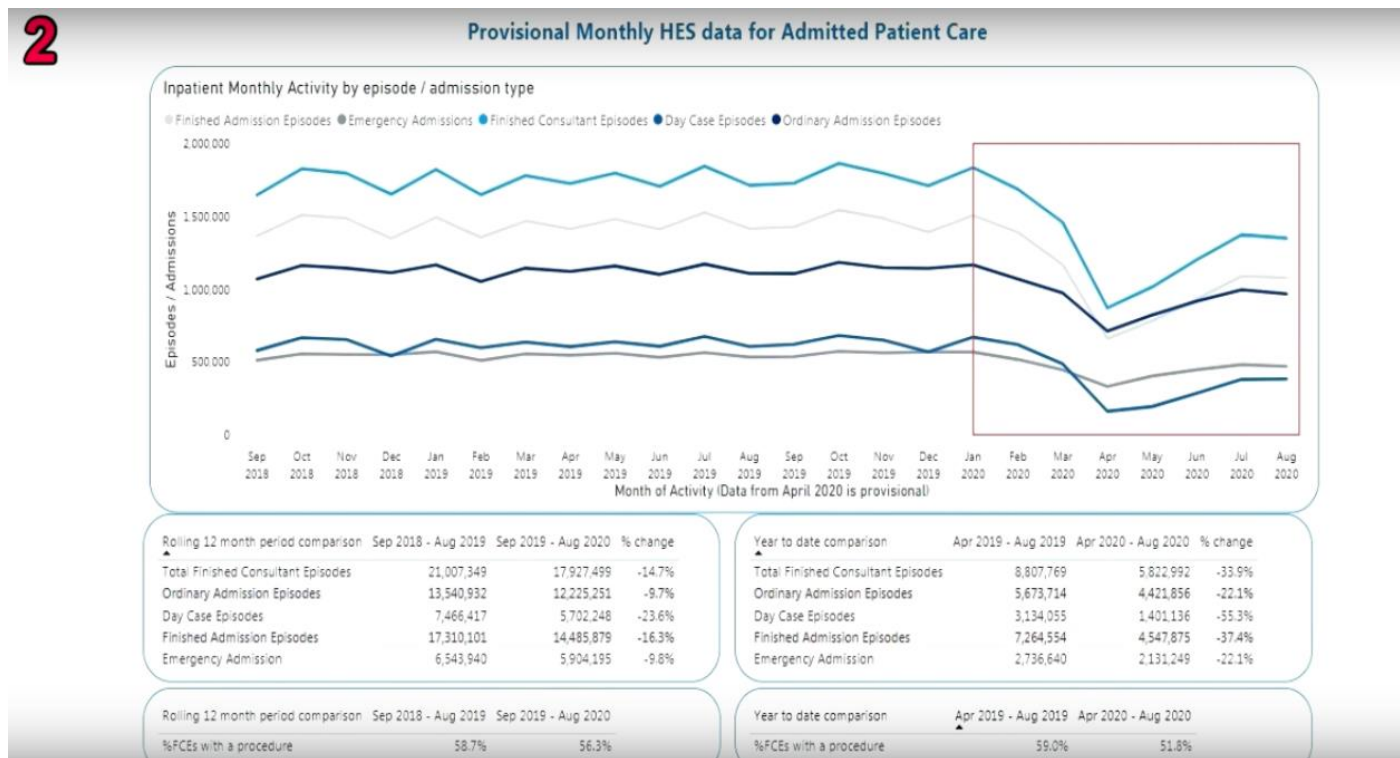

#1. In the provisional monthly data for outpatients, there is a dip right at the start of 2020. As you can see, the downward trend continues. 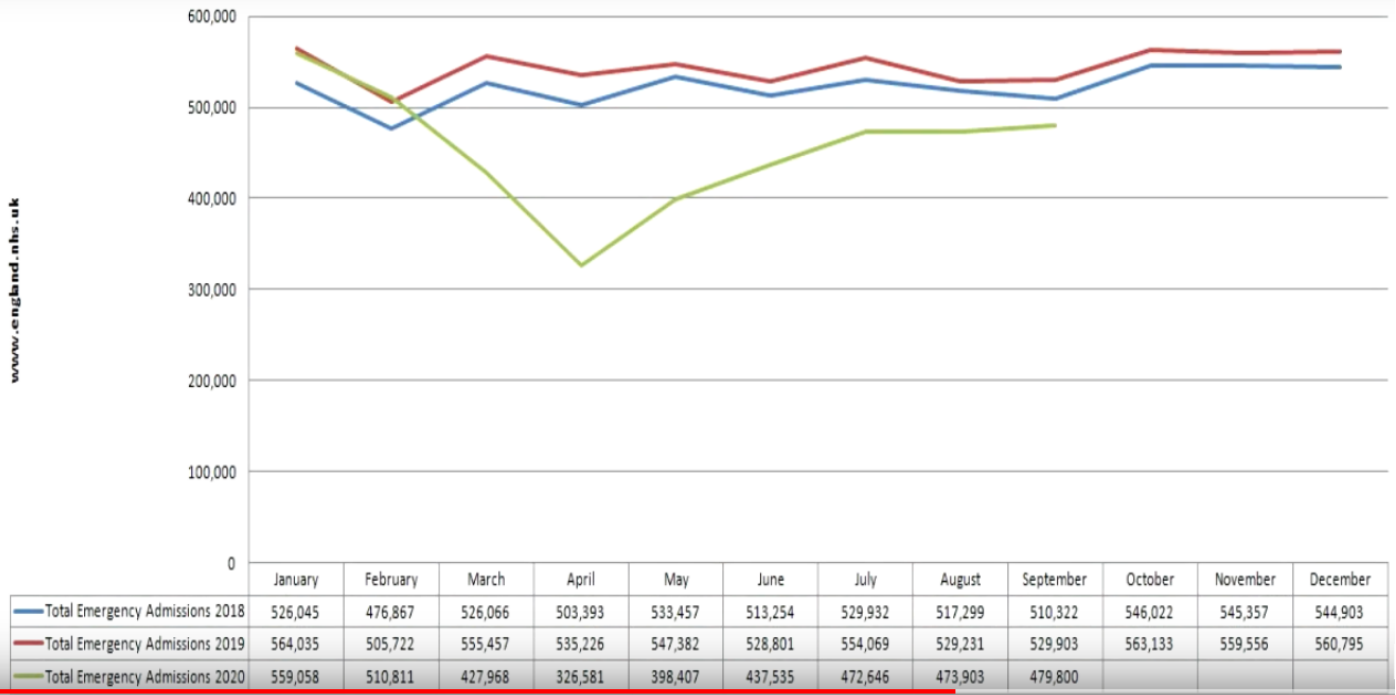
#2. As you can see in admitted patient care, the official NHS data shows that hospital admissions began to decline from the start of January 2020. The biggest and most noticeable dip was from March to April 2020, with a steady rise in admissions after that, but still well below normal levels.



#3. NHS total emergency admissions for Jan 2018 to Sept 2020 also shows a huge downward trend from January 2020. Accident & Emergency admissions fell sharply from Jan all the way until April 2020 when it began to rise, but once again, these fell well below normal levels.

NHS A&E Attendances Jan 2018 - Sept 2020 (Latest Figures)

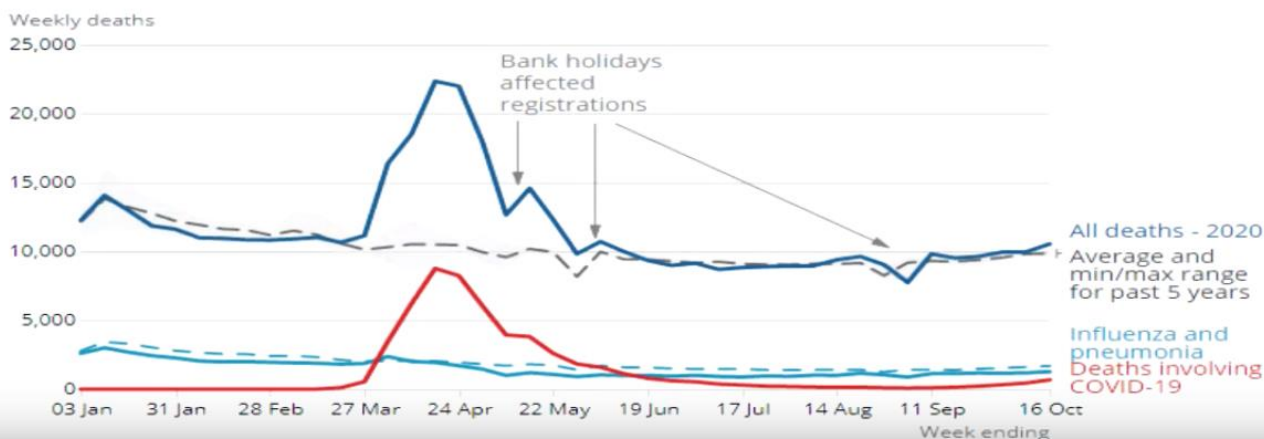


#5. ONS data for this graph changed after this version. A Portuguese appeals court has ruled that PCR tests are unreliable and that it is unlawful to quarantine people based solely on a PCR test.

The court stated, the test's reliability depends on the number of cycles used and the viral load present.

if someone is tested by PCR as positive when a threshold of 35 cycles or higher is used (as is the rule in most laboratories in Europe and the US), the probability that said person is infected is less than 3%, and the probability that said result is a false positive is 97%.
